prosecuting 3 people for fly-tipping. He encouraged attendance at the Thriving Communities Workshop to be held on 1st November.

- ii Cllr Drew sent a report which had been circulated before the meeting. He drew the Cllrs attention to National Inclusion week which was highlighted to employers that SEND adults were employable and would be useful employees. He said that "Strong and Steady" classes were keeping older people fit. There was an increase in payments for families housing Ukranian families. He noted that there were challenges to the County Council budget because there was a projected shortfall of £137m which meant savings needed to be found by 2025.
- iii Cllr Drew said Ms M Ware had been unhappy with the first report from the traffic survey contractors and she had sent it back to them to be re-done. Cllr Halle said he had asked Ms Ware for that draft report.
- iv Cllr Drew said HCC were unwilling to put up signs for the disabled parking bays (C/23/088a), because doing so would require a TRO which was a costly legal process. He had asked for the disabled parking bays to be re-painted. Cllr Halle commented that certain able-bodied users of the disabled bays parked there because they knew it was not enforceable. He said there were 4 such parking bays on the High Street and that enforcement should be part of the decision making. Cllr Drew agreed to take the matter further.

a. Disabled parking signage

C/23/110 Traffic Safety Old London Rd Project

Cllr Powell had contacted Cllr Adams-King as the final decision maker. He had replied to say he would speak to Cllr Drew for a briefing. Cllr Halle said that the Traffic Safety WG should deal with the matter from now on and although the members of the WG were no longer on the Council new members could join in order to take the matter forward and reach consensus. He said this new group should include members of the OLR community and the Primary School and would operate under SPC's terms of reference for WGs. The new members of the WG were agreed to be Cllr Porter, Powell and Halle. It was agreed that the focus was to be on safety around the school.

c. Cycle Path

TVBC were due to sweep away the detritus from the path. It was agreed that the Lengthsman should be asked to spray the weeds. It was felt that spade work was required to lift the overgrowth weeds. The Clerk said she would check if Community Service people could do this work. Cllr Powell suggested approaching the Cycling communities who use the path. Cllr Smith said he would approach the local farmer to cut back the hedging.

d. Defibrillator

C/23/116 80th Anniversary of D-Day

Cllr Halle said that Stockbridge had links to D-Day and it was important to commemorate the event. He said that Stockbridge always had beacons but the National Trust, as landowner, was wary about allowing them. He had been told that they would make the decision, close to the day, as to whether it could go ahead. Cllr Halle put forward the suggestion of a purpose made beacon (C/23/092). Cllr Powell queried the £5K cost. Cllr Halle said that grants should be obtainable. Cllr Jeffery said that TVBC would consider a grant if it was a permanent beacon. Cllr Halle said he would enquire from the National Trust.

a. Update on transfer

The Clerk confirmed that the site was now under Stockbridge Parish Council ownership.

b. Risk assessment for volunteers The risk assessment circulated before the meeting was agreed.

c. Plan for Initial Working Group

Cllr Smith had cut back the entrance but expressed concern that the site would attract caravans. Cllr Halle said that he knew of someone who was prepared to take some of the dead wood away. Cllr Halle commented that the project needed to be community led and it was important to pull in new community members. He asked the Clerk to order a new padlock and chain. All Councillors were invited to meet at the site 1st November at 2pm to start planning what should be done.
