The Clerk said the Council had agreed a reserve of £4000 in December. The Council agreed that other sources of funding, including the Fishing Club, should be approached for the remainder.

Cllr Drew had spoken to the Clerk to say he had spoken to Elliot Rowe of HCC rights of way to ask if the tarmacked area could be extended or scalloped. Mr Rowe had been open to the proposal.

f. Use of Pavement by traders

Cllr Jackson noted that when traders had tables and chairs on the highway it wasn't possible to get wheeled walking supports through. Cllr Bell said that the pavements weren't wide enough and HCC should either need to widen the pavement or enforce the rules. A member of the public, who was the Chair of Stockbridge Business Assoc, asked to speak and said that the rules were being applied in a haphazard fashion across Hampshire and TVBC seemed to have licensed other places with narrower pavements. He said businesses were trying to create a vibrant environment which people wanted to visit and he asked for the Council's support. Cllr Lawrence said it was important to consider the safety aspects. Cllr Bell didn't consider that the Council should be involved and the matter should be referred to HCC. This was agreed.

Traffic Safety

Cllr Bell, Mrs Jefferies, the Clerk and Cllr Drew had met with Mr Stuart Jarvis and Mr David Wilson of HCC. The minutes had been circulated to the Council before the meeting. Cllr Bell said that HCC appeared to be linking parking on the High Street with Old London Rd and this could mean parking restrictions there. He said parents would therefore need to park on the A30 and there was no safe A30 crossing. He said the results of the feasibility study were waited for but that Mr Wilson was willing to discuss Stockbridge as a whole.

Cllr Foord said it was important that Stockbridge didn't end up in a position of HCC imposing what they wanted to do on Stockbridge. Cllr Bell said that it was vital to obtain the residents agreement with any proposal. Cllr Lawrence pointed out that SPC did not have control over the road and if HCC saw reason to do something, they could do so without the SPC's support.

Stockbridge Parish Council supports this planning application. The building is historic and it will likely receive more investment compared to a commercial unit and it is noted that the building does require some work. Parking would be improved due to the net reduction in spaces generated by a commercial unit compared to a dwelling. A number of High Street dwellings in recent years have been lost to retail units, and reconverting this building back fully to residential (which it was prior to 1992) will help restore the balance between residential and retail. It is felt that because the building is already a dwelling with only two rooms with retail use that this loss will be outweighed by the reasons above.
